"Atleast IInd Class Bachelor Degree of recognized University. Fluent in both English & Punjabi speaking, should have pleasing personality and should be having training & work experience of E.P.A.B.X./Fax System/Receptionist etc. for atleast two years.

Punjabi: Should have passed Matriculation examination with Punjabi as one of the compulsory subject or any other equivalent examination in Punjabi language which may be specified by the Govt. from time to time.

Knowledge of Computer:

The candidate must have undergone a computer course of six months duration from a reputed institute."

Pay Scale: Rs.19,900/- Initial Pay (Level-2)

Note: The minimum pay admissible for the post shall be as per the notification of Finance Department dated 29.10.2020. Age: As per Punjab Govt. instructions, age limit for the above said post shall be as under:-
