#### **General Information & Conditions:**

- The total duration of the project is upto March, 2026. However, the selected candidate will be initially given appointment for a period of one year, which may be extended further upto the total duration of the project i.e. March, 2026, on the basis of performance of the candidate & availability of budget.
- The applicant must be a citizen of India.
- All applicants must fulfill requirements of the post and other conditions stipulated in the advertisement as on the last date of submission of application i.e. **20.12.2024**. They are advised to satisfy themselves before applying that they possess at least the essential qualifications laid down for the posts as on the last date of submission of application.
- In case of receipt of large number of applications, only short-listed candidates will be called for written test and interview. The criterion for short listing the candidates will be on the basis of marks obtained by a candidate in the essential qualifications and/or experience gained in the relevant field. The list of short listed candidates will be uploaded on the website of PSCST under 'Job Opportunities'.
- In case of Universities/Institute awarding CGPA etc. candidates are requested to convert the same into percentage based on the formula as per their University/Institute guidelines. Copy of conversion factor to be attached.
- The application for the said post should be accompanied by self-attested copies of the relevant educational qualification, experience certificate. The prescribed qualifications should have been obtained through recognized Universities/Institutions etc. Incomplete applications received without the required certificates/documents are liable to be rejected.

- g. Applications from employees of Government Departments will be considered only if forwarded through proper channel, certified by the employer that the applicant, if selected, will be relieved within 15 days of the receipt of the appointment orders.
