General Information & Conditions:

- a. The selected candidates will be given appointment up till 31.03.2023, which may or may not be extended.
- b. The applicant must be a citizen of India.
- c. All applicants must fulfill requirements of the post and other conditions stipulated in the advertisement as on the last date of submission of application i.e. 30.1.2023. They are advised to satisfy themselves before applying that they possess at least the essential qualifications laid down for the posts as on the last date of submission of application.
- d. In case of receipt of large number of applications, only short listed candidates will be called for written test/presentation and interview. The criterion for short listing the candidates will be on the basis of marks obtained by a candidate in the essential qualifications. The list of short listed candidates will be uploaded on the website of PSCST under 'Job Opportunities''.
- e. In case of Universities/Institute awarding CGPA etc. candidates are requested to convert the same into percentage based on the formula as per their University/Institute guidelines.
- f. The application for each-post should be accompanied by self-attested copies of the relevant educational

- qualification, experience. The prescribed qualifications should have been obtained through recognized Universities/Institutions etc. Incomplete applications received without the required certificates/documents are liable to be rejected.
