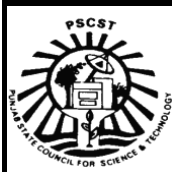

**General Information & Conditions:**

- The selected candidates will be initially given appointment for a period of one year, which may be extended further annually upto the total duration of the project, on the basis of performance of the

candidate/availability of budget.

- b. The applicant must be a citizen of India.
- c. All applicants must fulfill requirements of the post and other conditions stipulated in the advertisement as on the last date of submission of application i.e. **11.07.2022**. They are advised to satisfy themselves before applying that they possess at least the essential qualifications laid down for the posts as on the last date of submission of application.
- d. In case of receipt of large number of applications, only short listed candidates will be called for written test and interview. The criterion for short listing the candidates will be on the basis of marks obtained by a candidate in the essential qualifications. The list of short listed candidates will be uploaded on the website of PSCST under 'Job Opportunities'.
- e. In case of Universities/Institute awarding CGPA etc. candidates are requested to convert the same into percentage based on the formula as per their University/Institute guidelines.
- f. The application for each-post should be accompanied by self-attested copies of the relevant educational qualification, experience. The prescribed qualifications should have been obtained through recognized Universities/Institutions etc. Incomplete applications received without the required certificates/documents are liable to be rejected.
- g. Experience certificate submitted must be issued by the competent administrative authority of the concerned organization.
- h. Applications from employees of Government Departments will be considered only if forwarded through proper channel, certified by the employer that the applicant, if selected will be relieved within one month of the receipt of the appointment orders. - k. The decision of PSCST in all matters relating to eligibility, acceptance or rejection of applications, mode of selection, and conduct of examination/interview will be final and binding on the candidates.

**RELAXATIONS:**

- a. The upper age limit is relaxable upto 05 years for SC/BC category candidates as per Government orders in force on production of relevant certificate in the prescribed format signed by the specified authority at the time of interview.
- b. Upper age limit is also relaxable upto five years for the employees working in Council, Govt. Departments, autonomous bodies and public sector undertakings.
