The applications complete in all respect, along with testimonials, experience certificate etc. must reach this office **latest by 03.01.2022, through Registered/Speed Post/By Hand**. The name of post applied for and of the project must be super scribed at the top of the envelope. PSCST reserves its right to reject any or all applications without assigning any reason.

### General Information & Conditions:

- The total duration of the project is 5 years. However, the selected candidates will be initially given appointment for a period of one year, which may be extended further annually upto the total duration of the project, on the basis of performance of the candidate/availability of budget.
- The applicant must be a citizen of India.
- All applicants must fulfill requirements of the post and other conditions stipulated in the advertisement as on the last date of submission of application i.e. **03.01.2022**. They are

advised to satisfy themselves before applying that they possess at least the essential qualifications laid down for the posts as on the last date of submission of application.

- d. In case of receipt of large number of applications, only short listed candidates will be called for written test and interview. The criterion for short listing the candidates will be on the basis of marks obtained by a candidate in the essential qualifications. The list of short listed candidates will be uploaded on the website of PSCST under 'Job Opportunities'.
- e. In case of Universities/Institute awarding CGPA etc. candidates are requested to convert the same into percentage based on the formula as per their university/institute guidelines.
- f. The application for each-post should be accompanied by self-attested copies of the relevant educational qualification, experience. The prescribed qualifications should have been obtained through recognized Universities/Institutions etc. Incomplete applications received without the required certificates/documents are liable to be rejected.
- g. Experience certificate submitted must be issued from competent administrative authority of the concerned organization.
- h. Applications from employees of Government Departments will be considered only if forwarded through proper channel, certified by the employer that the applicant, if selected will be relieved within one month of the receipt of the appointment orders. However, advance copy of the application may be submitted before **03.01.2022**, 17.00 Hrs. IST.
- i. Candidates should specifically note that the applications received after the closing date for any reason, whatsoever (such as envelopes wrongly addressed, delivered elsewhere, postal delay etc.) will not be entertained by Council.
- j. Incomplete applications (i.e. without photograph, unsigned and applicable testimonials etc.) will not be entertained and will be summarily rejected.
- k. The decision of PSCST in all matters relating to eligibility, acceptance or rejection of applications, mode of selection, and conduct of examination/interview will be final and binding on the candidates.
- l. Canvassing in any form and/or bringing any influence political or otherwise will be treated as a disqualification for the post.

**RELAXATIONS:**

- a. The upper age limit is relaxable upto 05 years for SC and 03 years for BC category candidates as per Government orders in force on production of relevant certificate in the prescribed format signed by the specified authority at the time of interview.
- b. Upper age limit is also relaxable upto five years for the employees working in Council, Govt. Departments, autonomous bodies and public sector undertakings. This relaxation is admissible to such of the government servants as are working in posts which are in the same line or allied cadres and where a relationship could be established that the service already rendered in a particular post will be useful for the efficient discharge of the duties of the posts, recruitment to which has been advertised.
